**TERMS & CONDITIONS**

**Please Read Carefully**

- Auction -** Limited to 65 head of Horses. Deadline is March 1, 2010
- Consignments -** Consignments must be received by March 1, 2010 accompanied by a check or money order and Original registration papers with appropriate transfers, breeding certificates, etc... All consignments must be paid for before being assigned a number in the sale. If a check, registration papers, and consignment form, are not received at the time of consignment, a sale spot will not be assigned. Once a horse is consigned to the sale, withdrawals will be permitted only if a horse or horses receive an injury or acquires an illness which prevents the horse from meeting health requirements and with a certified vet certificate indicating same. These horses can be replaced free of charge prior to April 5 but must be of the same sex. If a horse is pulled from the sale after April 15, for any reason, you may consign another horse of the same sex for an added \$50.00 consignment fee. That horse must be consigned at the time of withdrawing the other horse. You may not bring a sub horse the day of the sale for any reason. If you do, that horse will not be allowed to enter the sale. There will be no refunds on any consignment fees. No Exceptions. A fee of \$275.00 to consign, plus 10% commission on horses sold and \$100.00 no sale fee will be charged.
- Registration -** The original certificate of registration along with the proper transfer of ownership form signed by the owner on record at time of consignment and other documents such as breeders certificate on mares that are in foal or any other pertinent paperwork. All registration papers must be current and in the name of the person consigning or selling the horse. **DO NOT** consign a horse unless the registration papers are in your name, otherwise they will not be accepted for the sale.
- Horses -** All horses must be AMHA or AMHR registered horses. Horses will sell in catalog order designated by Sale Management. Also any horse sold must have a good halter and broke to lead. All horses are to be body clipped, and feet blackened. Any horse needing additional grooming will be charged to consignor. Double Diamond will groom your horses and present the horses at sale time.
- Coggins** Coggins must be no older than 12 months for horses in the state or out of state.
- Health Papers** Horses must have 30 day current health papers.
- Absolutely no alley trading. If this is brought to the attention of the Sale Management, you will be asked to pay the 10% commission fee of the no sale price.**
- No horse that has been consigned to a Double Diamond sale in the past 12 months can be consigned.**
- Guarantees -** All guarantees will be solely between the Buyer & Consignor. Sale Management does not act as agent for or represent either the Buyer or Seller but merely provides an environment for bringing together the Buyer and Seller for the purpose of a sale transaction.
- Consignors or Sellers -** Will be solely responsible for any information submitted about his or her horse.
- Consignor -** Agrees to save and hold harmless and indemnify the Sale Management, and its agents and employees, from any and all claims, debt, damages, injuries, or liability, etc.
- Advertising** Will consist of 1 full page ad in Horse World, a full page ads in AMHR Journal. Mass mailing & e-mailing to bidders and consignors of previous sales, and AMHA & AMHR members. Also internet access to the sale catalog on the Double Diamond and MareStare web page, and on Lil Beginnings.

**Advertising -** If you would be interested in placing an ad in the Sale catalog, the deadline is April 5. Your ad must be camera ready or electronically transferred to the advertising personnel. Also, a group package to be in the catalog and a rotating banner ad while the sale is being presented. **All ads must be paid for in advance.**
